FUNCTION / ALCOHOL TERMS & CONDITIONS

While TRAC Incorporated encourages our guests to enjoy themselves it is important that customers understand the Terms and Conditions listed here are in place to protect everyone's expectation of a good time.

To ensure compliance with the Sale of Liquor Act 1989 and the TRAC Inc Sale of Liquor/Host Responsibility Policy it is agreed that all members, guests and visitors will abide by the conditions of the Sale of Liquor Act and the TRAC Inc Host Responsibility Policy. The Customer shall be responsible for the conduct of their guests *and by purchasing tickets to this event agrees to abide by the terms & conditions as listed in this agreement.* The person who purchases the tickets will be deemed the Customer Representative (host/hostess) and will be contacted by the Duty Manager, Committee Member or Staff should there be any issues arise.

In particular the following conditions will be strictly enforced:

1. This is an ADULT (18+) event. Persons under the age of 18 years are not permitted within function areas.
2. Any person purchasing alcohol that appears to be under the age of 18 will be required to show identification to verify age. If none can be shown, or Staff are not confident that ID is correct, service will be refused & the person will be required to leave.
3. It is an offence under the Sale of Liquor Act 1989 to sell or supply alcohol to an intoxicated person. Intoxicated patrons will be refused service at all times and will be asked to leave the premises.
4. No member, guest, or visitor shall purchase alcohol for, or supply alcohol to a person deemed to be intoxicated by Staff, the Duty Manager, or a Committee Member. Any person found supplying an intoxicated patron with alcohol will be asked to leave.
5. Offensive behaviour or behaviour that impacts on the enjoyment of others will not be tolerated. TRAC Inc, after consultation with your appointed representative, has the right to refuse service and evict those whose conduct is deemed inappropriate
6. Any person who is deemed as intoxicated prior to entering the racecourse will be refused entry.
7. Any person who attempts to breach the BYO Alcohol Restrictions will be refused entry or if found to have deliberately done so after payment of admission charge will be evicted and no refund given.
8. The "loading" of drinks on tables is not permitted. No more than 3 drinks at a time will be served to one person up until Race 5, then only TWO drinks per person will be served until the bar closes.
9. All bars will close 15 minutes after the last race OR when deemed necessary by a TRAC Official or the Duty Manager.
10. The Club reserves the right to invoice the Customer for any damages resulting from inappropriate actions by your guests. Any such damages will be communicated with the customer prior to being invoiced.
11. A reasonable standard of dress is required... described as "SMART CASUAL."
This is defined as a standard of attire worn to quality restaurants/bars. Those wearing Work Jeans, Sweat Shirts, Swandry's, Hoodies, Singlets, Shorts, Sandshoes, Jandals or any similar clothing not of an acceptable standard will be refused entry.
